Training: 19:48

2017 Field Day - Mike Mulligan indicated for everyone to look for a new flyer with information on registration changes. There was some feedback from last years group. Spring fire came up with idea for high rise class. That did not get legs because the person who was heading it is no longer with Spring Fire Department. Spoke to Emergency Ministries about doing a suicide recognition course. Two individual classes would have to happen. But the contractor they use to put on those classes was to expensive to put the class on. This year the field day will be in memory of Michael Godfrey along with something special to be done at the memorial service.

Bryan Harris - Pointed out that TEEX has changed their forms so everyone needs to pay close attention to this. David Wade indicated their is a pocket safety guide that all students will get.

Mike Mulligan- Eveyone knows that the gear has to been NFPA 1971 standard, clean shaven and eye protection. Mark Bitz asked if these safety requirements were in the flyer. No further questions

Training Cadre - Rodney Reed - We finally have some movement on training coordinators throughout the county. Their will be four meetings over the year. They have developed a survey and are waiting on TEEX before they get together with all department coordinators. They are working on having a TEEX training in Tomball. They had a meeting with Ben Kennedy with TEEX. They have a lot of classes that are created but then dont make. It is as much the fault of TEEX for accepting the classes as it is for the groups creating them.

2016 statistics are together. Up 10% on fire, investigations up 75%. The program making huge differences. We are getting calls we have never had before and would not have gotten until we started this program of calling us. Inspections was up over

200%. We keep hearing about the slow down because of oil prices. The bottom line, we are extremely busy right now. Lead time 7 days or less. Make sure contractors call early if they want an inspection. Seeing some major impacts on financial planning and business models.

Richard Lieder - Question about Cy-Fair schools and their construction.

Mike Montgomery - Budget Approved - Looks like we will get funding for a some more people. If you haven't seen NFPA 1072, professional standards for Hazardous Material Responders. This is a guide for training for Hazardous Materials Responders. Bill Anders - Having some medical going on and he has asked for prayers

Rodney Reed - Broadband Jamming went on just before the Super Bowl - FCC is looking into it. Suspected to be faulty equipment.

Chris Turrentine - A few departments have still not signed the Interlocal Agreement for Grace, PSTRAX will be contacting department that do not use their system to train them on how to use the program for GRACE tracking. Training coming up - ICS 300-400, Inspectors Class In March - Hazardous Tech sometime in the year.

David Wade - Activated for weather event - Level 3. Started receiving intel regarding potential forecast worse than the other day. Start Sunday and last into Tuesday. - Moisture levels are indicative of an October time frame. Look for some emails soon from the weather service and from Harris County. David is the Executive Director for the Greater Harris County LEPC. You should be receiving Tier II. There are some areas that will have RMP facility. Just like the WEST, Texas plant that exploded. New rules are going to be in place for these facilities to get with the local fire departments and work closer with them. David is encouraging all departments and ESD'S to get more involved with the LEPC. Next Meeting LEPC is April 19th.

Marty Menke who coordinates Cert and did her final CERT Rodeo- She got home and found her husband deceased. Keep her and family in prayers. Sunday February 19th Funeral- Rodney Reed will send information out.
